### Upholding the GCBA Mission Statement

Dear Colleagues:

The Gwinnett County Bar Association Board has convened to discuss the events that have been transpiring in our communities and those worldwide following Mr. Ahmaud Arbery's, Ms. Breonna Taylor's, Mr. George Floyd's, and many others' premature deaths. Any omission of personal and public acknowledgement is not acceptable. The Gwinnett County Bar Association Board condemns racism, bigotry, and hatred in all its forms. The purpose of this statement is to highlight the steps that the Gwinnett County Bar Association is going to take to combat the systemic racism in our community.

Our Mission Statement is "to uphold and defend the Constitution of the United States and of Georgia and maintain representative government; to advance the science of jurisprudence; to promote the administration of justice; to uphold and honor the profession of law; to apply our knowledge and experience in the field of the law to the promotion of the public good; to encourage cordial intercourse among the members of the corporation; to correlate and promote such activities of the bar organizations in Gwinnett County as they are in the interest of the legal profession and of the public."

It is our mission to uphold and defend the Constitution of the United States and of Georgia. The Preamble to the Georgia Constitution echoes the Preamble to the United States' Constitution, in stating that the citizens of Georgia adopt this Constitution to "insure justice to all, preserve peace, promote the interest and happiness of the citizen and of the family, and transmit to posterity the enjoyment of liberty." Through the formation of committees and through community outreach, not only as part of our Law Day celebrations but also throughout the year, we will attempt to build better dialogue with the Gwinnett County Courts and Judiciary to insure justice and promote peace. The Gwinnett County Clerk of Superior and State Courts announces the commencement of e-filing for criminal cases, which began June 24, 2020 via Tyler Technologies' Odyssey eFileGA. Attorneys and self-represented parties now have the option to electronically file into existing criminal cases.

Tiana Garner, Chief Deputy Clerk of the Gwinnett County Clerk's office, stresses the importance of participation in this effort. "It will not only make access to justice more convenient, but it will also aid in slowing the spread of COVID-19 by decreasing in-person contact at the Clerk's Office. 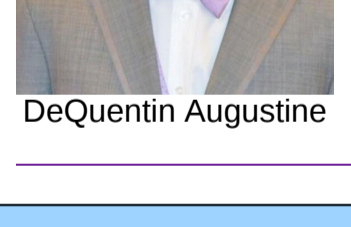

## LEGAL UPDATES AND ARTICLES

### UPDATE TO USCR RULE 6.1

The Supreme Court entered an order modifying Uniform Superior Court Rule 6.1 effective July 2, 2020. The revised rule requires as follows:

Filing in civil actions every motion made prior to trial, except those consented to by all parties, when filed shall include or be accompanied by citations of supporting authorities and, where allegations of undisputed fact are relied upon, supporting affidavits, or citations to evidentiary materials of record. In circuits utilizing an individual assignment system, the clerk shall promptly upon filing furnish a copy provided by the attorney or party of such motions and related materials to the assigned judge or the judge's designee. When an attorney or party e-files a motion or any response, the attorney or party shall notify the opposing parties and the assigned judge or the judge's designee by e-mail of the motion or response contemporaneously but no later than 24 hours after e-filing. Amended effective July 2, 2020.

### LEGISLATURE PASSES HATE CRIME LEGISLATION

On June 23, 2020, the Georgia Legislature passed House Bill 426. HB 426 would allow enhanced criminal penalties to be levied against those who target their victims on the basis of race, gender, sexual orientation, sex, national origin, religion, or physical or mental disability.

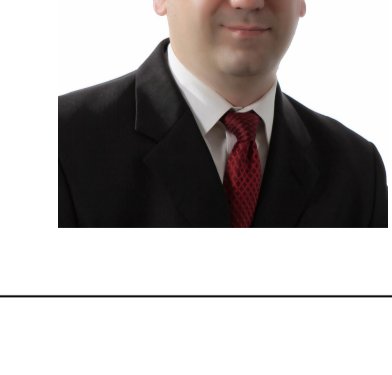
The bill, co-sponsored by GCBA member and House Representative Chuck Elstratton (R-Dacula), has been hailed as "a defining moment in Georgia," by House Speaker David Ralston (R-Blue Ridge). The bill will now go to the Governor's desk to be signed.
